### Notice regarding Partial Changes in Articles of Incorporation

ERI Holdings Co., Ltd. (the “Company”) hereby announces that it has resolved, at a meeting of the Board of Directors held on July 16, 2024, that a partial change in the Articles of Incorporation will be referred for discussion and approval at the 11th Annual General Meeting of Shareholders scheduled for August 29, 2024. The details are described below.

#### 1. Purpose of changes in Articles of Incorporation

In light of accelerating business expansion, the Company proposes an amendment to the current Article 2 (Purpose) of the Company’s Articles of Incorporation to include new business purposes in addition to minor change reflecting change of the Act.
