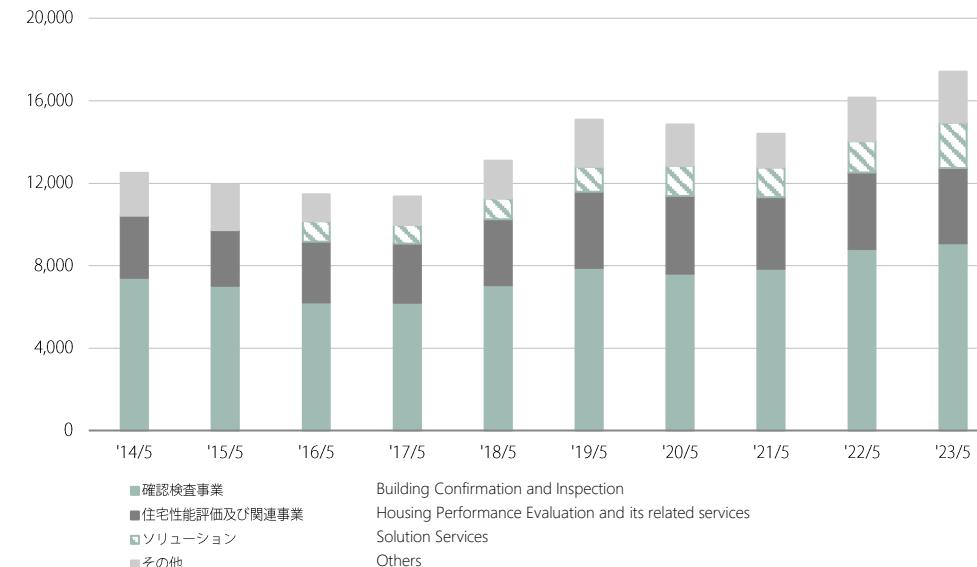

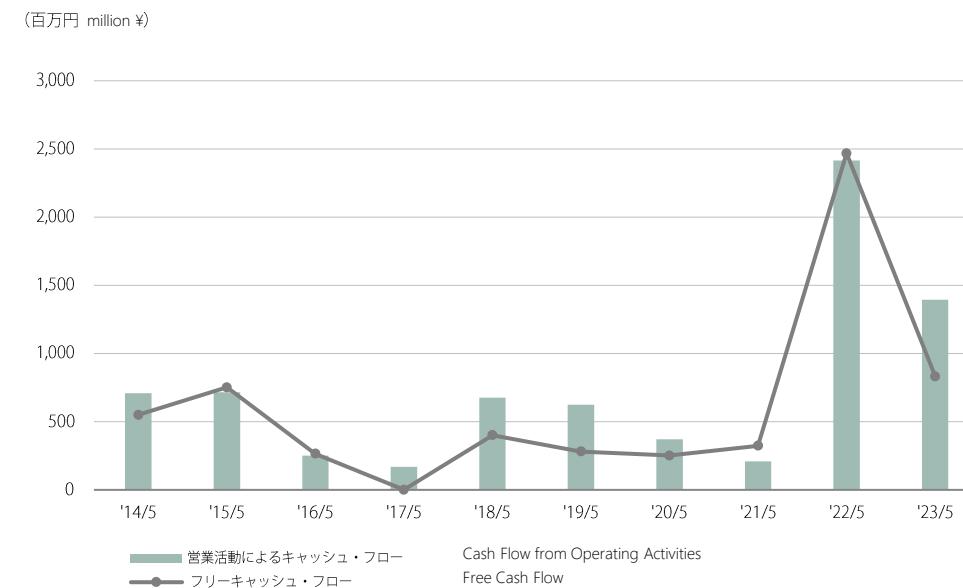

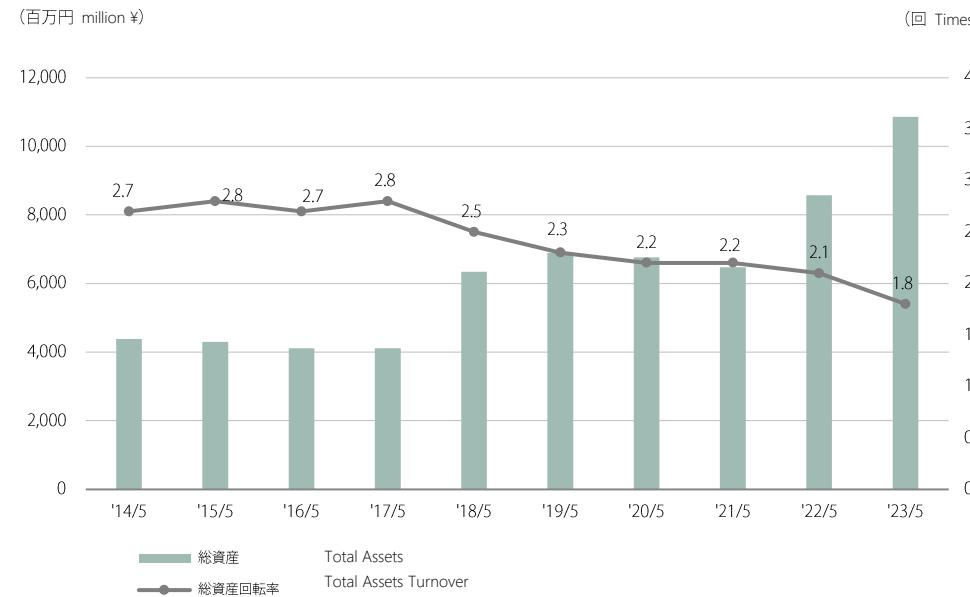
営業活動によるキャッシュフロー、フリー・キャッシュフローの推移  
Cash Flow from Operating Activities, Free Cash Flow



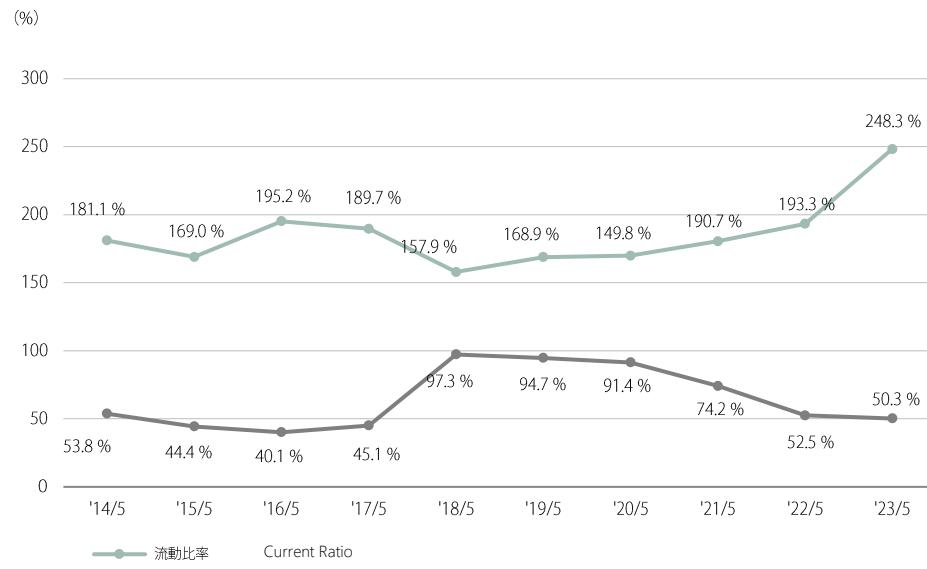

### 総資産、総資産回転率 Total Assets, Total Assets Turnover



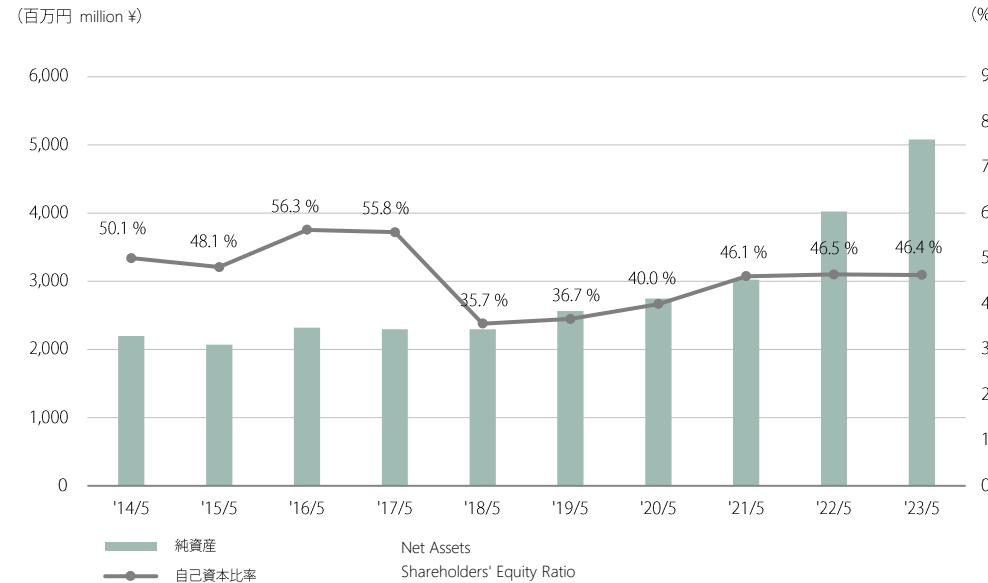

Net Assets, Shareholders' Equity Ratio



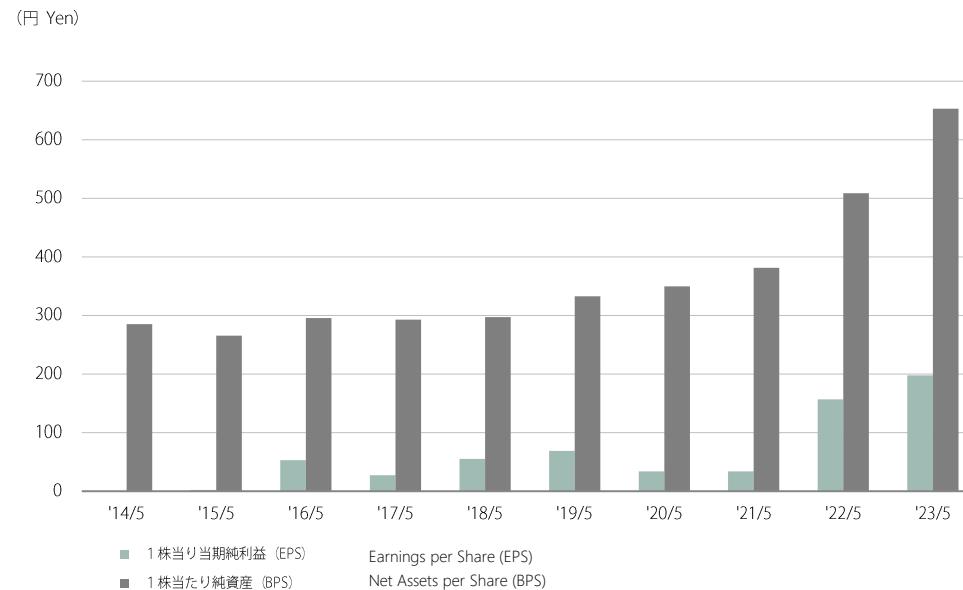

Return on Equity (ROE), Return on Assets (ROA)



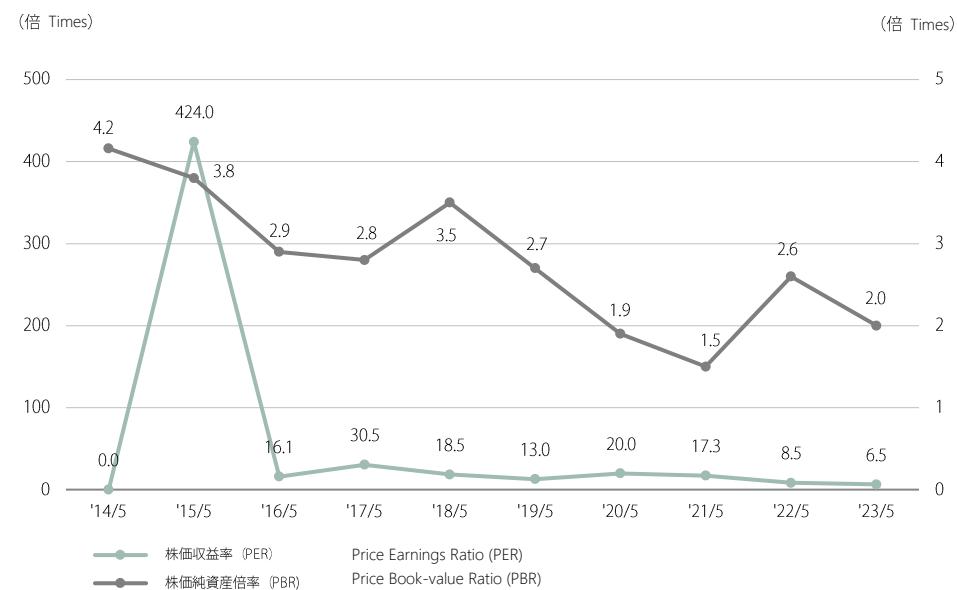

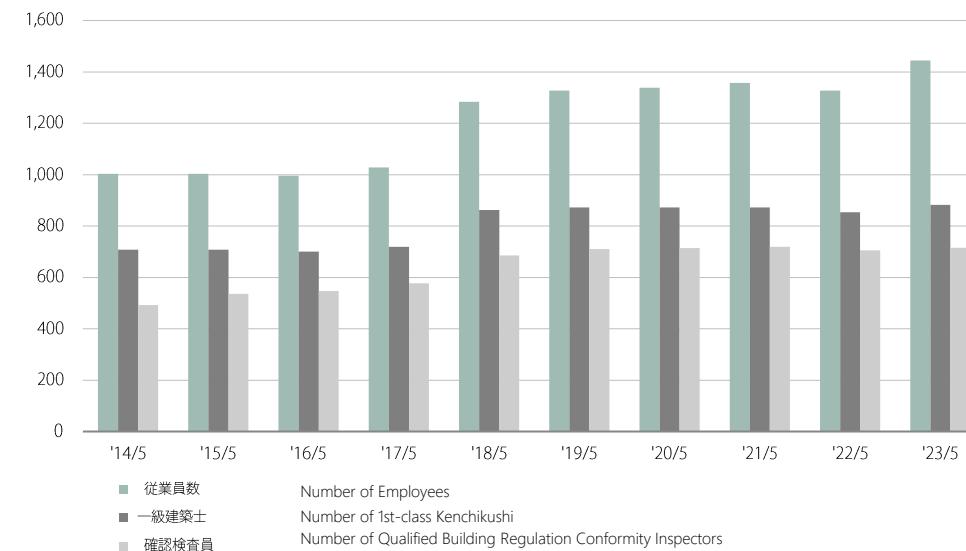

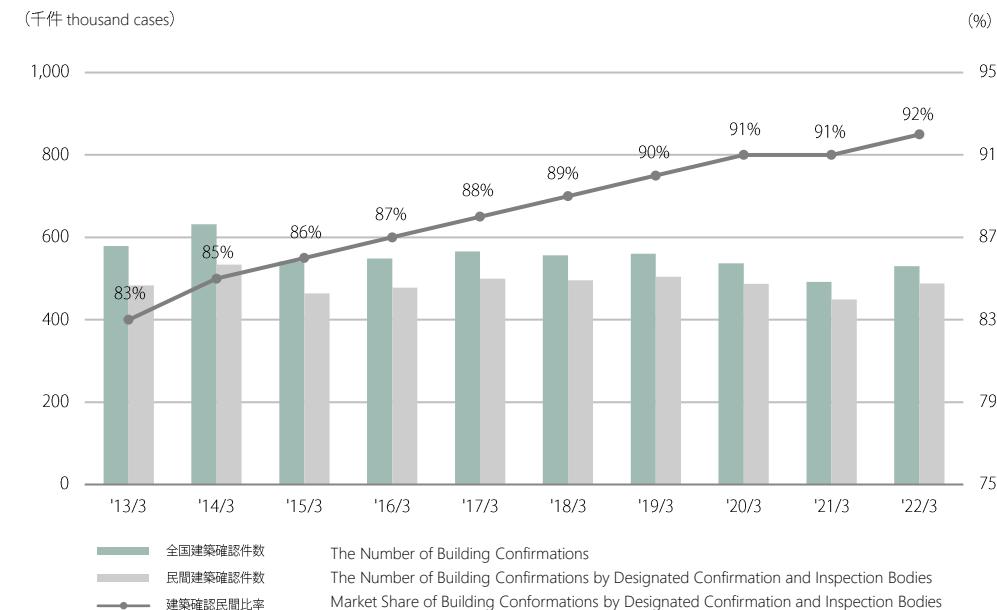

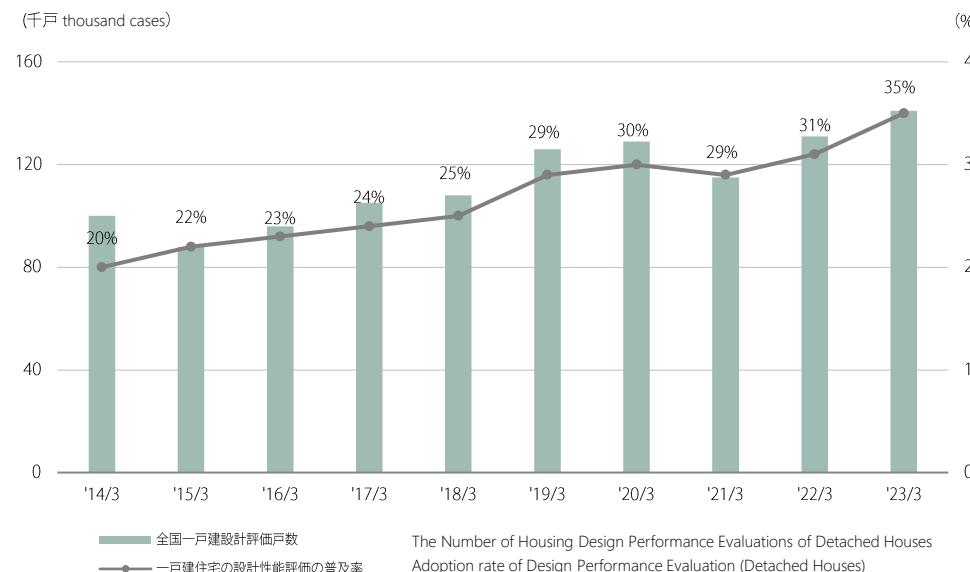

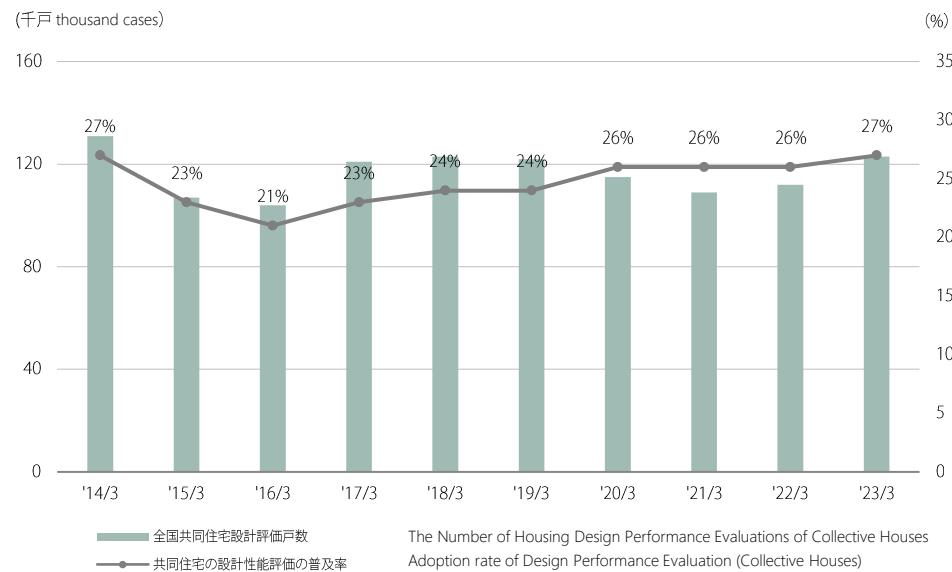
## 全国一戸建て 住宅性能評価戸数、普及率
